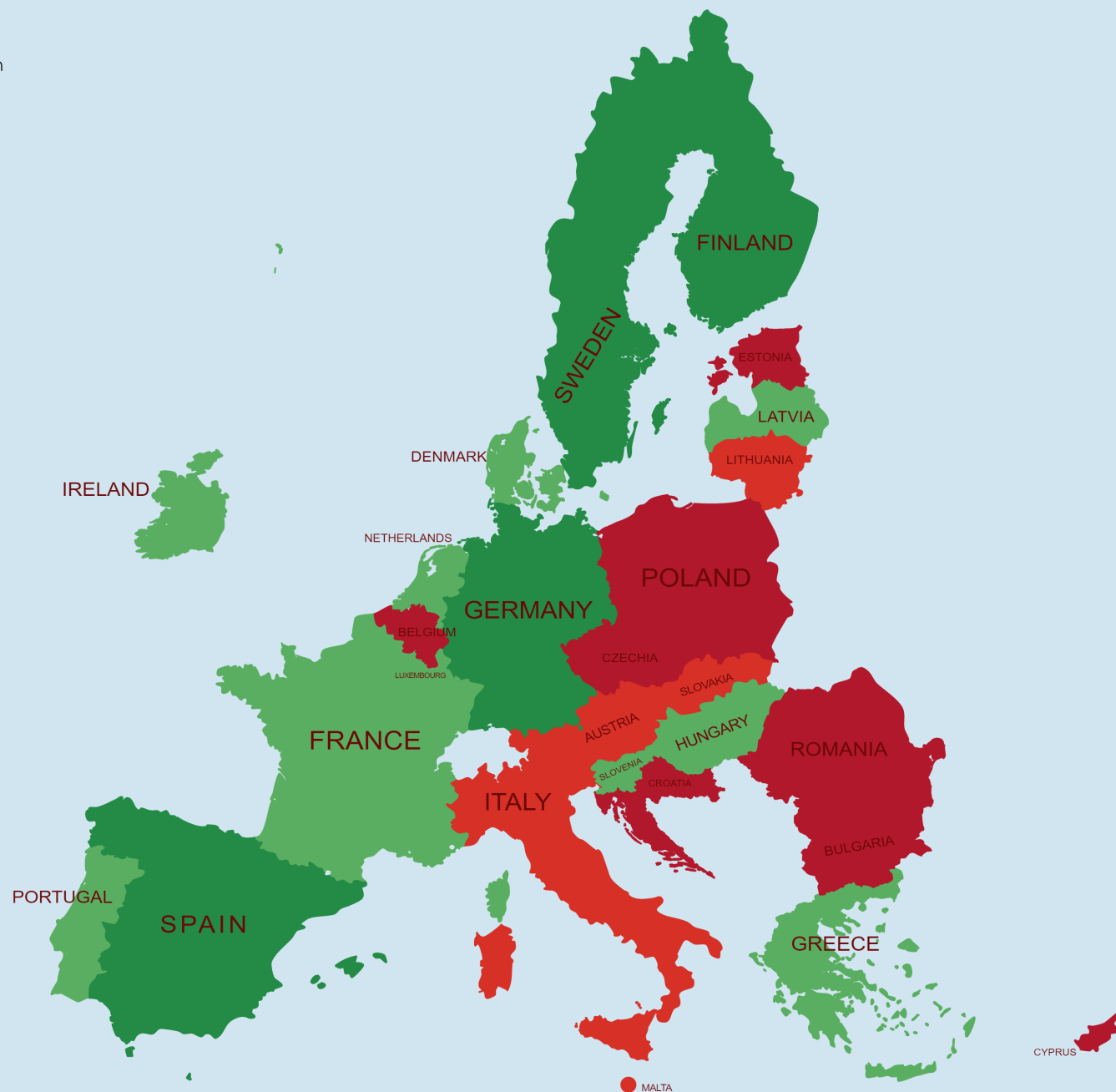

## To reach EU climate neutrality each country must do its bit

<b>Belgium</b>	No climate neutrality objective (some regions have climate-neutrality targets). National long-term strategy (LTS) <a href="#">models</a> 85-87% emissions reduction* by 2050 in non-ETS sectors.
<b>Bulgaria</b>	No climate neutrality objective and no national LTS.
<b>Croatia</b>	No climate neutrality objective. National LTS <a href="#">models</a> 56.8-73.1% emissions reduction by 2050.
<b>Cyprus</b>	No climate neutrality objective and no national LTS.
<b>Czechia</b>	No climate neutrality objective. National LTS <a href="#">models</a> 80% emissions reduction by 2050.
<b>Estonia</b>	No climate neutrality objective. National LTS <a href="#">models</a> 64-80% emissions reduction by 2050.
<b>Poland</b>	No climate neutrality objective and no national LTS.
<b>Romania</b>	No climate neutrality objective and no national LTS.
<b>Austria</b>	Climate neutrality by 2040 not set in law but in a <a href="#">government coalition plan</a> . National <a href="#">LTS</a> is under revision to reflect the change.
<b>Italy</b>	Climate neutrality by 2050 not set in law, only envisaged in national LTS ( <a href="#">modelling</a> of 84-87% emissions reduction by 2050).
<b>Lithuania</b>	Climate neutrality by 2050 not set in law but in the national <a href="#">LTS</a> and the <a href="#">National Climate Change Management Agenda</a> .
<b>Malta</b>	Carbon neutrality by 2050 not set in law, only envisaged in national <a href="#">LTS</a> .
<b>Slovakia</b>	Climate neutrality by 2050 not set in law, only envisaged in national LTS ( <a href="#">modelling</a> of 70-80% emissions reduction by 2050).
<b>Denmark</b>	Climate neutrality by 2050 in <a href="#">law</a> .
<b>France</b>	Carbon neutrality by 2050 in <a href="#">law</a> .
<b>Greece</b>	Legislation <a href="#">under way</a> to set climate neutrality by 2050.
<b>Hungary</b>	Climate neutrality by 2050 in <a href="#">law</a> .
<b>Ireland</b>	Climate neutrality by 2050 in <a href="#">law</a> . Ireland has not submitted its national LTS.
<b>Latvia</b>	Legislation <a href="#">under way</a> to set climate neutrality by 2050.
<b>Luxembourg</b>	Climate neutrality by 2050 in <a href="#">law</a> .
<b>Netherlands</b>	95% emissions reduction by 2050 in <a href="#">law</a> – likely sufficient for climate-neutrality.
<b>Portugal</b>	Climate neutrality by 2050 in <a href="#">law</a> .
<b>Slovenia</b>	Climate neutrality by 2050 in <a href="#">law</a> .

\* Unless specified otherwise, all emissions reduction percentages are compared to the baseline year 1990.

<b>Finland</b>	Carbon neutrality by 2035 ( <a href="#">law</a> under revision to reflect this change), with a 90% emissions reduction target for 2050.
<b>Germany</b>	Climate neutrality by 2045 in <a href="#">law</a> .
<b>Spain</b>	Climate neutrality “before 2050” in <a href="#">law</a> .
<b>Sweden</b>	Climate neutrality by 2045 in binding parliamentary <a href="#">act</a> .
